

Dear Brothers and Sisters.

What another crazy year it has been in this unpredictable world. Once again our members have risen up and have done the best they can to make it through these rough times. We have the ongoing pandemic, loss of hours, supply shortages, conflict in Europe and rising inflation. These issues have caused our members great emotional and financial hardship

Let us talk about some good news, hours are coming back month over month for our members. As the hours increase hopefully, we will be able to reinitiate members we have lost over the last two years. We have the new infrastructure bill that will pump \$1.2 trillion dollars into the economy, and we will need industrial painters. Painters District Council #14 with DC #30 and DC #58 will be receiving a grant from the federal government for an Industrial pre-apprentice program to the tune of \$975,000. The council will be reaching out to the contractors once we get all the information. The President has also signed the executive order for PLAs on large-scale federal projects of \$35 million or more. This order will affect \$262 billion in federal construction contracting for 200,000 workers. This order will increase hours for our members and contractors.

Painters District Council #14 is also working on a more diverse workforce with working with Chicago Women in the trades (CWIT) and Chicago CRED. These organizations will help train and guide women and at-risk youth with pre-apprentice programs to become future Union members. Our JATC will be hosting a pre-apprenticeship with each of these organizations in April with

the goal of getting new apprentices into our program.

Over the counter Covid test are now available to all insured members under the Cigna plan at any in-network pharmacy. No need for a prescription and the plan covers up to eight test a month for each covered family member. If you purchased a Covid test on or after January 15, 2022, you can be reimbursed up to twelve dollars by going to Cigna.com and completing a claim form. If you wanted to be vaccinated or boosted, we have on going vaccination sites or simply go to your neighborhood pharmacy.

These times can be exceedingly difficult emotionally on our members and their families. The strain on our mental health is causing a lot of mental anguish that can be overcome with assistance. If you or a family member needs assistance, I beg you to call our Member Assistance Program (MAP). We have a great Member Assistance Program with Northwestern Medicine and help is just a phone call away at 1-888-933-1327 and is available 24/7/365 days a year. The Member Assistance Program can help with any range of issues or simply offer consultation and coaching.

The Chicago Young Lions had a food drive and received donations from all the locals to stock our very own food pantry at the Council. We will assist members who may have fallen on hard times and may need some help affording groceries. The pantry opened on April 13, 2022 and currently is taking appointments for the 2nd and 4th Wednesdays of the month. To schedule an appointment please contact Helen Chung at (312)421-0046. Please take advantage of this fantastic opportunity if you are in need.



Painters District Council #14 will be out early this election year to educate our members on some especially important legislative issues and political candidates. We need a politically educated member to understand why we are supporting certain legislation and candidates in the upcoming elections. WORKERS' RIGHTS AMENDMENT

Throughout decades union labor has been on the decline on an average of -.4% per year. Politicians and special interests' groups have been taking away workers freedoms, livable wages, and safe working conditions. The rules that are in place now, Employers have the upper hand and its difficult for the working class to organize. Every working-class citizen should have their right for a good living wage, health benefits, pension, be able to drive a new car, send your son or daughter to college. And now we have an opportunity of a lifetime. The Illinois General Assembly proposed to amend the Bill of Rights of the Illinois Constitution. This Amendment known as the Workers' Rights Amendment provides every employee union or nonunion rights to collectively bargain over wages, hours, terms and conditions of employment. WRA gives working class people of Illinois a voice on the job so we can safe working conditions. WRA protects workers from current or future anti- worker Springfield politician from ever taking away your working rights.

The Workers' Rights Amendment reads as follows;

Proposed Amendment to the 1970 Illinois Constitution

Explanation of Amendment

The amendment would create a new section in the Bill of Rights of the Illinois Constitution. It will guarantee the workers to have the fundamental right to organize and bargain collectively through representatives of their own choosing for purpose of negotiating wages, hours, and working conditions, and to protect their economic welfare and safety at work. No law shall be passed that interferes with or negates or diminishes the rights of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and workplace safety, including any law ordinance that prohibits the execution or application of agreements between employers and labor organizations that represent employees requiring membership in an organization as a condition of employment. You are asked to decide whether the proposed amendment should become part of the Illinois Constitution.

YES For the proposed amendment to add
Section 6 to Article VII of the Illinois
NO Constitution

WRA will be the very first vote on the ballot. Vote Yes for Workers' Rights Amendment. Finally, the working class has a vote for the working class.

Anna's father, Joe Valencia, a painter out of District Council 58 taught her the values of the working class. Being raised by a blue-collar Union painter Anna knows the impact of being laid off, the importance of families having health and welfare benefits, and the value of a pension. Anna's father Joe is now eligible for retirement and is appreciative that he can receive a pension from our IUPAT.

Anna has been a member of our District Council 14 family since she became City Clerk in 2017. Painters' District Council #14 first endorsed Anna for City Clerk and now along with District Council #58 is endorsing Anna for Secretary of State. As City Clerk Anna has worked passionately to make the City Clerk's office more accessible to the public and implemented policies to improve the lives of Chicagoans. Anna established the City Key Municipal ID program, making government issued ID cards free and available for all residents. She has improved access to city benefits, like discount prescription drug programs and library services. She also spearheaded the first Mobile City Hall, which brings city services directly to communities across Chicago.

District Council 14 believes that Anna will bring the same energy, drive and innovation to the Secretary of State's Office. Not only does District Council 14 believe in Anna, but so does our current Secretary of State Jesse White and Governor JB Pritzker both endorsed Anna for Secretary of State. In addition she has the endorsement of U.S. Senator Dick Durbin and Tammy Duckworth. Vote Anna Valencia for Secretary of State.

Union Sisters and Brothers,

As we look at 2021 in the rear-view mirror and now moving ahead into 2022, I'm hopeful we can learn from the challenges that were laid before us and now directly ahead of us. In my 35 years of being a tradesman and Union Glazier in the Chicagoland area I have experienced several downturns. Throughout these rough times, one thing was for certain; I always knew I had the support from my Union and my family.

As Covid-19 has continued to test our strength, I'm hopeful we all have learned from the weaknesses that were exposed. Whether it be our health or our personal decisions to vaccinate, this pandemic has exposed the intricacies of how we all perceive one another. At this time, I'm elated to say the future looks prosperous to all our construction markets in the Chicagoland area where our members work and live.

More importantly, I depend on the feedback from our Business Representatives along with our Organizing and Political departments. Our BA's have been beating the streets relentlessly by checking commercial worksites, municipal water towers, schools, etc. As this is just a few of the many tasks our Reps engage in daily. The Organizing Department has been working on various campaigns to unionize contractors and workers. Our Political Department has been



spreading awareness and lobbying to our political constituents to keep our District Council's political agenda moving forward. These daily actions by our staff help our District Council make informed decisions to boost our unionized market share. I want to thank them all personally for their hard work and unwavering dedication to OUR GREAT UNION.

As a last note, you will see course schedules listed in this newsletter for the Journeyman Glazier's AGMT (Architectural Glass & Metal Technician) certification and Journeymen STAR (Safety Training & Awards Recognition) upgrade classes offered by the Painters and Glaziers JATC's to help our members LEARN and EARN. Please take advantage of these educational classes and opportunities to better your profession and maintain your ability to continue providing for your families.

GERALD C. HARMS SCHOLARSHIP FOR PAINTERS AND TAPERS

Once again it is that time of year for scholarships. The Gerald C. Harms Scholarship is available to Painters and Tapers who are employed by contributing contractors and meet the requirements. This scholarship is available to all students attending college the 2022 Fall Semester. Every year request forms are sent out to all members working for contributing contractors. If you have not received one please contact the Council and request an application. There is no limit on how many dependents can apply from each family for the scholarship so if you need more than one application please let us know. Full time Union officials, employees of the District Council, School, or Local are NOT eligible for scholarship assistance.

comply with the following:

Due to the overwhelming number of applicants each member must

- 1. Applicant must be a member or an immediate family member of a current card holding member.
- 2. Union member must be employed by a contributing contractor and have 3.5 credits in the last Five years. The calendar year starts April 1st and ends March 31st. In order to earn a pension credit for a calendar year you must work 1400 hours in the year. Applicant must have a high school diploma or equivalent
- 3. Applicant must be in the top 50% of his/her High School class.
- 4. Applicant must be attending a four-year accredited College or University.

If you meet the requirements for the scholarship you will receive an application that college applicant must complete and submit to the Council. Each application specifies requirements that MUST be sent in with each completed application or it will be denied. These requirements also pertain to previous scholarship recipients, each year we review each completed file. The Scholarship committee does not have a fulltime employee to answer questions which means you are responsible for

sending the correct information, so please be sure to follow instructions on the application or the application will be denied.

Once we receive your completed application the scholarship committee will review the information and notify you by mail if you have been approved. If you are not eligible you will also receive a notice in the mail.

The Gerald C. Harms Scholarship program is one of our most successful programs that we feel helps our membership and their families. This program was started because of the foresight of former Business Manager Gerald Harms, who started the fund in 1991, to help families with the high costs of a college education. Since the fund has been established over 5 million dollars has been given away to hundreds of members and their families.

Last year over 70 applicants received scholarships totaling over \$300,000. So, don't miss out this year make sure to get your applications completed and in. Every year you can apply even if you did not receive one the prior year. If you have any questions, please call the Council.





My name is Al Barraza Painter's District Council 14 new Director of Organizing. I was asked to come up with an article for this newsletter. While I could go into a DC14 Organizing report, I have decided instead to dedicate this article to our recently retired former Director of Organizing Mark O'Donnell.

Like most of us in the trade, Mark O'Donnell grew up from humble beginnings in a working-class family on the southside of Chicago in Mount Greenwood. It was in 1977 at a job fair that Mark came across CEDA, which stands for Community and Economic Development Association of Cook County Program. The program gave community members a chance to learn some basic trades skills that could lead to union jobs. CEDA provided Mark the opportunity to get a paid stipend to learn a trade, so Mark decided to try the Sign Painting Trade. In order to complete the CEDA program Mark enrolled in the School of Letter and Design. Shortly after that Mark had the opportunity to join this great union and he did when he started with Letterman Signs out of Mokena. Little did he know at the time that those early choices would lead him to where he is today.

On January 31st, 2022, Director of Organizing Mark O'Donnell's carrier long goal of achieving retirement status finally came to fruition. For 40 years, 23 of which were as a Business Representative, Mark served and represented Local 830 Sign, Exhibit and Display, Wood Finishers, and Metal Polish Finishers. The last two years of his career Mark was appointed as Director of Organizing where he was assigned 4 organizers. A big reason he was appointed the position was due to his tenacity in organizing workers that were employed by Intersection. Intersection was contracted by CTA to wrap its buses with advertisements. Workers at Intersection were disgruntled due to paltry pay, poor health and welfare plan, lack of pension and broken promises made by Intersection. Mark along with Business Representative Todd Overdorff took the time to meet and understand Intersection's workers and decided to help the best way they could. It was first and only time that DC14 has had a successful bottom organizing campaign that resulted in 13 workers becoming union members. Bottomup organizing is perhaps the hardest way to organize workers and the company they work for. Mark recognizes this campaign as one of his most memorable and his most proud moments at DC14.







Although his tenure as Director was brief the impact Mark O'Donnell had was significant and highly effective. Marks more recent and according to him, says his proudest achievement was the work he did on the Industrial Water Tank Campaign. Mark led 4 organizers, as well as effectively coordinated efforts with DC30 and DC58 to chase out contractors from out of state performing work on Elevated Water Tanks here in Illinois. From filing Freedom of Information requests, and Department of Labor prevailing wage complaints, attending bid openings, town hall meetings, countless hours researching bad contractors, documenting their violations, and pursuing their every move tenaciously. Mark leadership and guidance instrumental in regaining a stronghold in the Industrial market here in Illinois. The campaign and its effectiveness have been touted by our International and serves as a model for the rest of the country. Since the beginning of his career in the union, Mark has served our union with the utmost pride, distinction, and dedication. The work ethic and tenacity that he brought to the Organizing Department helped create bigger market share and hours to our Industrial contractors and members under their employ. He left behind big shoes to fill but the Organizing Department and myself are looking forward to continuing and building on what brother Mark O'Donnell helped get started. With all that being said, congratulation Mark O'Donnell may your retirement be as rewarding as your career!

Introduction: The Architectural Glass & Metal Technician (AGMT) program is a ANSI accredited personnel certification process featuring a third-party, independent assessment of a glazier's knowledge and ability. AGMT tests experienced glaziers' fundamental knowledge, skills, and abilities through written and hands-on assessments.

Glazing Technician Competencies: There are 7 major categories that are assessed by the AGMT Certification Program.

Systems



Sealants & Gaskets, etc.



QC & Failure Prevention

Program Prerequisites: The AGMT Certification is designed to validate the knowledge, skills, and abilities of an experienced glazier. In order to become an candidate for certification, and applicant must first meet the below Prerequisites:



Read and sign the AGMT Candidate Agreement



Possess OSHA 10 certification or higher



Demonstrate at least 7,500 hours of glazing related work experience



Submit a Photo of applicant

Achieving Certification: In addition to meeting the programs Prerequisites, candidates must pass an assessment to become AGMT-certified. The assessment is divided into two tests, a Knowledge-based test (KBT) and a Performancebased test (PBT).


Knowledge-based (KBT): The knowledge-based test is a 125-question, multiple choice test for which candidate will have 2 hours to complete.

Performance-based Test (PBT): The performance-based test is broken into three (3) seperately timed Sections.

- Curtainwall (3-1/2 hour time limit)
- Storefront/Entrance (2 hour time limit)
- Sealants (45 minute time limit)

AGMT CERTIFICATION AND GLAZIERS UNION LOCAL 27 MEMBERS

Starting in the spring of 2021, select Glaziers' Local 27 Members began preparing for the Architectural Glass and Metal Technician (AGMT) Certification. The AGMT Certification, which is ANSI accredited, is designed to validate the knowledge, skills, and abilities of an experienced Glazier. Candidates must pass an assessment which is divided into two tests, a Knowledge-based test (KBT) and a Performance-Based test (PBT).

The candidates were assessed on their general knowledge of the glazing trade during a KBT prep class and registered to take the exam. Due to Covid restrictions the first round of written tests were administered remotely via computer. In August of 2021, our first paper/ pencil test was conducted at our training facility. We had 10 members test remotely and 24 members test in person and all 34 members successfully PASSED the KBT (written portion).

After successful completion of the KBT, members began their training for the PBT by taking at least 2 - 8 hour prep classes at the school. In late August, a PBT was held at the training facility with 14 of the members who had previously completed the KBT. All 14 members Passed the PBT and became fully Certified AGMT Glaziers!

As of February 21, 2022, we are proud to report that Glaziers Local 27 has 31 members who carry the full AGMT Certification and 20 members who are half-way there as they have passed the KBT and are waiting to take the PBT. To date every Local 27 member who has taken either exam has PASSED!!



SPOTLIGHT PAINTERS UNION LOCAL 273

Along with the high ideals of the bond of craftsmanship brought to this country in the 1880's, the Bohemian Painters were among the pioneers of the then promotion of an eight-hour work day.

The Bohemian Painters' Union 273, which had its start not necessarily with a racial or nationalistic idea in mind, but a two-fold purpose, namely: the establishment and perpetuation of the artisan spirit, and secondly, the protection and organization of a powerful labor organization.

It was in the Spring of the year 1886, at the time of the Eight Hour Movement and Strike, when some farsighted members of the painters' guild came to the conclusion that by organization only, they can achieve a better existence.

It was on the eve of the fateful day, May 4th, 1886, the day of the historical events of the Haymarket Meeting. From this

day, in reality, begins the organization activities of our Local.

And so on this 3rd day of May a greater number of employers and workers came together in the hall of the Bohemian English School to confer about the necessity of the organization and the founding of the Bohaemian Union. The meeting was called to order by Mr Victor Sedlacek, and Mr. John Vodak accepted the duty as the Secretary of the meeting. Thirty two members were enrolled including ten painters that applied for membership at the meeting. An election was held and Joseph Pondelicek was elected President.

September 18, 1895, Brother Jacob Tazelaar, the organizer of the Brotherhood of Painters, attended the meeting. The meeting was opened by President Brother Anton Kalina. Organizer Tazelaar presented the charter and announced that our Union will receive the number 273, and that

our name is: "Bohemian Painters and Decorators Union, Local 273".

In 1970, the Local celebrated our 75th Anniversary. Brother Harry Demien was the Treasuer of the local and Apprentice Coordinator for Painters District Council 14.

In 1995, the Local celebrated our 100th Anniversary. Gerald Thanos was our Financial Secretary and Business Representative. Laddie Vachula was our President at the time. Following Laddie's retirement, Brother Dennis Nickon served many years as our President. Frank Sustersic followed Jerry Thanos as Financial Secretary and Organizer.

Today Brother Mark Riha is our President and Frank Sustersic is our Financial Secretary, and Bruce Russell is our Committee Chairman.

The Local is sad to say we recently had to say goodbye to our Sister Denise Sanford who lost her battle with cancer. Denise

was a Local Union Trustee and delegate to Painters' District Council #14. She began her career with DC 14 Local 273 as an apprentice in December of 1991 and graduated to journeyperson in January of 1995. She was an extremely talented painter and very active fighting for womens' rights and supporting Women in the Trades. Denise was one of the original members of PDC #14 Womens Committee that started in 2015 and continued to be active in the group until the end. We truly will miss this incredible woman.

We have active and retired members throughtout PDC 14 Jurisdiction and from various nearby states. We are very active politically, supporting Pro-Labor candidates from Chicago and surrounding communities. Our meeting hall is at the Berwyn Eagles Aerie #2125 at 6309 W. 26th Street, Berwyn, Illinois 60402. You can follow pro-Union news on our Facebook page Chicagoland Area Painters Local 273.

NEW MATERNITY BENEFIT 2022

EFFECTIVE SEPTEMBER 30, 2021

PAINTERS AND TAPERS UPCOMING VOLUNTARY DRUG TESTING

Painters District Council 14, in agreement with the Finishing Contractors Association of Chicago (FCA), has established a voluntary drug and alcohol testing program. The program shall be open to all painting and taping members of Painters District Council 14. The member will incur no cost. The testing period will run from June 1, 2022 thru August 31, 2022.

Members may voluntarily submit themselves for testing and, if they test negative for alcohol or drugs, be issued a "drug-free" card. This card will be valid for a period of two years from the date of issued. Persons who do not pass the drug and alcohol test will not be eligible to test again for a sixty-day period. Any re-test shall be at the member's own expense.

Employers may request persons holding drug free cards and request a list of members with drug free cards from the union to assure a drug free workplace. It is strongly suggested to do the voluntary drug testing to open up more employment opportunities for you.

PAINTERS DISTRICT COUNCIL #14 HAS ADOPTED THE NEW PAID MATERNITY LEAVE PROGRAM/BENEFITS

BENEFITS FOR ELIGIBLE EMPLOYEEES PURSUANT TO LMCI MATERNITY LEAVE PROGRAM.

LMCI has approved funding for a maternity leave program to be administered by local health and welfare funds. The program creates a benefit for 6-weeks of paid leave for all working participants who give birth. If the participant gives birth by caesarean section, the paid leave may be extended to 8 weeks. Further, if a participant is certified by their health care provider as being unable to work during their pregnancy, they may receive up to 6 months of paid leave prior to giving birth.

The weekly benefit amount is based on two-thirds (2/3)

of the participant's regular weekly pay, up to a maximum of \$800 per week.
