LETTER FROM THE BUSINESS MANAGER/ SECRETARY TREASURER

Well another year has come and gone. This year has sure been an eventful one for District Council 14 members. As we look forward to the upcoming holidays let's pause and look at some of the highlights of the past year.


DC 14 negotiated a new contract with both the Painters and Drywall Taper Contractors Associations. Utilizing the survey that was sent out to all our painter and taper members the agenda was set on what our members wanted. With a strike looming, we secured a 4-year contract that benefited both labor and management while guaranteeing higher wages, a secure health insurance, and pension over the next 4 years.

Our website (pdc14.com) has given our members better access to what is happening in their union. It also has created a mechanism to track contractors and general contractors that are both union and non-union, so we can get a better grip on work being performed in DC 14's area, as well as hold our representatives and organizers accountable for their job performance. Using this information, we have stepped up pursuing more union work for our members.

Numerous pickets and demonstrations have turned non-union jobs into man days worked by our members. Our latest "Job action" has been pursuing "Intersection Media" currently doing work for the Chicago Transit Authority. You may have seen our demonstrations or heard of them on the radio. The Law firm Goldberg, Weisman and Cairo had a \$500,000 contract with Intersection Media for advertising on buses all over the city. To support the District Council #14 and Union labor they have pulled their contract with Intersection Media. We thank them for the supporting our Union and all Union work.

With the new contract we have developed a new Market recovery initiative, which helps our contractors bid competitively on jobs that would normally go non-union. So far, this year it has brought in approximately 15,000 union hours with full wages and benefits for DC 14 members. We look forward to this growing even larger with our contractor's support in the upcoming years.

LETTER FROM THE BUSINESS MANAGER/ SECRETARY TREASURER

We will be returning to Blue Cross/Blue Shield for our Health insurance on January 1, 2018. In an effort to save our funds money and a promise of little inconvenience to our members we changed our insurance in 2017 from Blue Cross /Blue Shield to Cigna Health Care. During this past year we received many complaints from our members that there were problems with providers and claims being covered. Because of inconveniences to our members and their families we decided this change proved to be too much.

The Painters and Tapers STAR (Safety Training Award Recognition) gave away their 11th car. The Glaziers raffled off their 10th Car at their Star banquet this year. Both programs also raffled off big screen tv's, computers, gift cards and numerous of other prizes. All in the effort to keep our members safe on job sites.

Painters and Tapers District Council 14 has given over \$312,000 in scholarships to our members families going to college this year.

We held our 13th annual picnic for District Council #14 members and their families, with over 1500 attendee's. A good time was had by all with good food, clowns, games and live music.

The young Lions committee has increased in size and participation. Holding meetings on the second Tuesday of each month. This year's Young Lions events included a paint ball event, food drive with the "Golden can awards" for the local that collects the most canned food for the food pantries, Football banquet at the District Council, and a young workers Investment seminar held at the apprenticeship school.

The DC 14 Women's committee on Organizing has continued growing and lending a hand with different events from helping with the Annual book bag give away, Labor Day parade, and having a Candle Light Bowling event. They also participated in the annual Women Build Nations Conference at the Hyatt Regency McCormick place. Where over 1600 women from around the nation were in attendance. They also hosted a Chicago Women in the Trades Job fair at the Painters training facility, where young women wishing to enter the trades receive some hands-on training demonstrations by the Dry wall, Glazing, and Painting instructors.

Glaziers Local 27 has had 73 new apprentices starting at their training facility. The Glaziers, Painters and Tapers are looking at becoming a fully accredited training facility. This gives the graduates of all three training programs the potential of receiving college credits after graduating from the apprenticeship program.

There is a merger of locals 273 and 180 that is currently in the process and should be complete by January 1, 2018.

We have had numerous politicians visit both our Union Hall and our training facilities to better educate them of what our union and our trades are all about. Most were amazed at our Training facility and programs that are required to be a true tradesperson at no cost to the tax payers.

We have had Dollars Against Diabetes Collections, Political Rallies, Blood Drives, Urban league book bag give away, Numerous volunteer painting events for special Olympics, veterans homes and the underprivileged.

These are but a few of the things going on behind the scenes at the Painters District Council. As we enter the holiday season know that your union is working to make next year even more successful.

Better yet come get involved with the union to help make 2018 the best year ever.

Business Manager/Secretary-Treasurer Painters District Council #14 Organizers work very hard every day monitoring Painters District Council #14 jurisdiction. We do our best to maintain and fight for all workers that do our work and don't have a voice on the job site. Our organizing team takes on some of the most unscrupulous Contractors in Northern Illinois.

It seems like a common theme as of lately is the misclassification of workers as "Independent Contractors". This is where a contractor lists their employees as independent rather than employees. Employers do this to avoid paying taxes, unemployment and worker's compensation insurance. Being able to prove this is a long task for our organizers as it takes an abundant amount of hours to earn the trust of the misclassified workers. After they earn their trust our organizing team will inform the workers about their rights. It is a long process but when you complete a case it is extremely gratifying for both parties involved the worker and us (DC#14).

We have had great success this current year with the job actions that we have taken. A few examples of job actions that we turned around are:

- Best Western Hotel on LaSalle & Ohio Street in Chicago
- Fitness Center located at 5556 S. State Street in Chicago
- The Sign Painters at White Sox Park in Chicago
- The Water Tower in New Lenox, IL
- Menards in Lake County, IL
- The Glaziers at Midtown Club

We currently have an organizing campaign against Intersection Media. They do the promotional wrapping on the buses and trains for the Chicago Transit Authority (CTA). All of the jobs they are doing in Chicago would create a work opportunity for some of our members.



Our BMST John Spiros has recently added two new Organizers to our team, Ruben Valdivia and Al Barraza. We are excited to add them on our team and have them on board. Your activism and participation in organizing efforts can be a tremendous help for the future of our industry. WARNING: FAILURE TO REPORT ANY ON THE JOB INJURIES CAN BE HARMFUL TO YOU . . .



I want to talk to you about a very serious subject: **ON THE JOB INJURIES**. The most important thing on a jobsite is "YOU". Some people think If they are injured on the job and do not need immediate medical attention that it's a good idea to take a wait and see approach and not to mention the incident to their employer. This is a horrible idea because when an accident is not reported, an employer can claim you were never injured at work and deny you medical treatment and benefits for missed time from work. The workers' Compensation Insurance carrier will also question why your employer did not report the accident on time, and your private health insurance will not pay for treatment for work related injuries. Reporting an accident properly will prevent many potential problems.

As we say safety is the number one factor on the job that should always be followed. Sometimes accidents do happen no matter how safe you make the site and not to the fault of the member. So, what should you do? If there is an accident on the jobsite make sure you report it to your foreman or superintendent immediately, and to your Union. I tell you to do this to protect yourself, in case something you think is minor turns out to become a bigger problem on a later date. Some members are reluctant to tell their company because they think they might lose their job or be laid off. If your

contractor does try to terminate you do to an injury you are protected by the Collective Bargaining Agreement. If you do not report an injury and at a later cannot return to work, you will be doing no good for you or your family.

Generally, the employee must notify the employer as soon as practicable, but no later than forty-five (45) days after the accident. To avoid any future problems, I strongly suggest you notify the employer immediately after the accident occurs. I have received calls from members that did not report their injuries until months after the required frame of time, and now are upset that Painters' District Council #14 legally can do nothing to help them. Remember we cannot help you if you do not help yourself by reporting the incident, no matter how slight you think the injury is, immediately. The report can be filled out with an accident report form from the company or the employer can fill it out online from our website. If you are injured, please contact me at 312-421-0046 ext. 265.



District Council 14 Women's Committee on Organizing helped to host and organize the International Union of Painters and Allied Trades (IUPAT) Caucus with participants from all over the United States. We like to thank our women for their efforts in making this a great event.







CONGRATULATIONS 2017 PAINTER AND TAPER SCHOLARSHIP RECIPIENTS

These days a college education is a must for our younger generation, but it comes with a high price tag. One of the things Painters' District Council #14 is most proud of is our scholarship program. Because of the foresight of former Business Manager Gerald Harms, who started this fund in 1991, we are lucky to have this fund to help our Union members and their families with the high costs of colleges.

In the past 5 years alone, we have given away over One Million Dollars in scholarships.

Every year in the Spring request forms are sent out to all members who work for contributing contractors for the scholarship program. Once the request form is filled out

by the member and returned to the Council an application will be sent back to the member. There is no limit on how many dependents can apply from each family for the scholarship. Every year you must fill out the application and fulfill each of the requirements *even if you have received a scholarship previously*. If the applicant does not fulfill these requirements their application will be denied. In this case the applicant may apply the following year.

This year over 75 applicants received a scholarship totaling over \$312,000. We would like to congratulate these recipients and wish them much success in their future endeavors.

PPO PARTICIPANTS/CIGNA MAJOR ANNOUNCEMENT

Beginning January 1, 2018 your PPO network will change BACK to Blue Cross/Blue Shield.

Benefits and coverage will remain the same. There will be no other plan changes. It will be imperative that as of January 1st you visit only doctors who accept BCBS if you wish to have the best possible coverage.

This is the first of several notices that will go out before years end. Future mailings will give information on receiving new insurance cards, phone numbers, etc. The original move to Cigna was projected to save the Fund money and the possibility to enhance benefits. Unfortunately, there were many issues and the transition did not go smoothly. The Trustees felt going back with Blue Cross/Blue Shield was in the best interest of the membership. The Trustees apologize for any inconveniences either of these changes will or has caused. The Health and Welfare Fund remains in a strong financial position. There is no concern about decreasing benefits or rising costs.

PAINTERS LOCAL UNION #184

Painters Local 184 was chartered on March 15, 1887. The Local was established by Eastern European immigrants who resided in the Southeast side of Chicago. Local 184 currently has a diverse ethnic mix and consists of Painters and Drywall Finishers.

The Local has a rich history of its membership being involved within the District Council leadership and apprenticeship program. Local 184 has the distinct honor of having one of their own hold the title of the first ever Drywall Finishing Instructor/ Coordinator. Joseph Perch helped develop the curriculum and program for the JATC. Mr. Perch eventually went on to serve as an elected Business Representative for DC 14. James Watte also served as an instructor and coordinator at the apprenticeship school. Matthew Chammoro (Drywall Finishing), Joseph Tyrakowski (Industrial Painting), and Veronica Leal (Painting-Wall Covering) all serve as JATC instructors. The current elected Business Representative is Andrew Perch.

The current meeting location is the Marrs-Meyer American Legion Hall located at 11001 S. Depot St in Worth, Illinois. Meetings are held on the second Wednesday of each month at 7pm. President Jose Alcala extends an open invite to any and all Union members to stop by and say hello.

Local 184 is proud to have an active membership. Participation is ongoing with all DC 14 activities. Some of those include: political volunteers, phone banking, picketing-handbilling, food drives, and charity endeavors. Members also participate within their local community. They have donated their time and skills on various painting projects. Members have been able to enhance their communities by painting a veterans home, playground equipment, VFW Hall, and a women's shelter.
